

# EXPRESSION OF INTEREST

## **BOCRA SUPPLIER DATABASE**

The Botswana Communications Regulatory Authority ("BOCRA or the Authority") is a statutory body established under the Communications Regulatory Authority Act of 2012 (The Act). The Authority is mandated to promote efficient provision of communications services throughout the country. BOCRA invites prospective suppliers and service providers to express their interest in doing business with the organisation by applying to be included on the BOCRA Supplier Database for a period of twelve **(12) months**. #### **COMPLIANCE REQUIREMENTS**

Interested companies should express their interest by completing the Supllier Database Registration Form accessible from the website *www.bocra.org.bw*. Completed forms should be accompanied by the following documentation:

- a) Cover letter detailing company details and category/s applied for,
- b) Contact details of authorised company representative,
- c) Company Profile with physical and postal addresses,
- d) Copy of valid Tax Clearance Certificate or Exemption thereof issued by BURS,
- e) Copy of PPADB Registration Certificate under relevant codes,
- f) Copy of Certificate of Incorporation,
- g) Copies of shareholding and directorship documents,
  h) Proof of nationality of Directors and Shareholders (certified copy of Botswana national identity (Omang) or Passport),
- i) Certified copy of Trading License (where applicable),
- j) Certified copy of EDD Certificate (where applicable),
- k) Two (2) reference letters for the categories applied for from past clients of not more than three (3) years back (added advantage).

#### **EVALUATION CRITERIA**

The assessment criteria shall be based on: a. Submission of all compliance information as stated above, b. Capability and Experience.

Company Profiles and all supporting documents should be submitted not later than **10:00HRS** on **20 NOVEMBER 2020** or such other later date as the Authority may advise in writing, to the following address:

- 5. Prospective suppliers will not be reimbursed for any expenses incurred in preparation of their submissions,
- 6. Youth, Women and People Living with Disabilities are encouraged to register.
