Ladies and Gentlemen;

Let me offer you a very warm welcome to this important consultative workshop co-hosted by the Ministry of Transport and Communications and the Botswana Communications Regulatory Authority. It is a real pleasure and great honour to have so many stakeholders here with us today in this fine city of Gaborone.

I would like to thank you all for heeding our call and accepting the invitation to attend despite your busy schedules in your respective businesses. As usual we have a full agenda, and I very much want to make sure we have time for our discussions so I will be very brief.

Globally, broadband continues to be at the top of the global political agenda and this was clear at the World Conference on International Telecommunications, WCIT-12, which took place in Dubai in December 2012. There was universal consensus at that international conference that broadband was the future. I am pleased to note that our Government encourages investment in international telecommunication networks and this will promote competitive wholesale pricing for traffic carried by our operators.

I am confident that investment in infrastructure and capacity development will play a very important role in furthering broadband rollout around Botswana, and will bring the Internet within reach of the 2 million people who are still offline.

## Ladies and Gentlemen;

What we are going to discuss here today should address the fostering of an enabling environment for the greater growth of the Internet. If anything our recommendations should specifically call for greater broadband investment and should express support for multi-stakeholder investment model.

Today is a unique opportunity to air the issues as you see them, and this forum will enable all stakeholders to contribute their unique perspective to the discussions and help Botswana chart a common course forward.

I welcome you all once again Ladies and Gentlemen as I leave the podium to pave way for the Honourable Minister to speak with you.
