1. The Botswana Communications Regulatory Authority (BOCRA or the Authority) hereby invites 100% citizen owned companies as stated under Section 76 (2) of the Public Procurement Act, to tender for the Supply and Delivery of Networking Equipment (Firewalls, Switches and Routers).

2. Procurement Method: Open Domestic Bidding

3. Bidders who are domiciled in Botswana must in order to be considered for the tender, be registered with the Public Procurement Regulatory Authority (PPRA) under the following categories:

Code 203: Electrical, Electronic, Mechanical and ICT Supplies

Subcode 01: Electrical and Electronic Equipment, Spares and Accessories (includes ICT, photographic equipment and others)

4. Citizen youth-owned companies shall purchase the ITT at 50% of the fee as per **Presidential Directive CAB 14 (B)/2015**.

5. Preference margins will be applied to qualifying bidders in line with the Economic Diversification Drive (EDD).

6. A non-refundable deposit of **BWP285.00 (Two Hundred and Eighty-Five Pula Only)** VAT inclusive payable by bank transfer or deposit at the following banking details, is required on collection of the tender documents:
