PROVISION OF CONSULTANCY SERVICES FOR THE REVIEW OF SPECTRUM PRICING POLICY FOR BOTSWANA

1. The Botswana Communications Regulatory Authority (BOCRA or the Authority) hereby invites local and international companies to tender for the Provision of Consultancy Services for the Review and Development of a Spectrum Pricing Framework and Policy for Botswana.

2. **Procurement Method:** Open International Bidding.

3. Bidders who are domiciled in Botswana to be considered for the tender, must be registered with the Public Procurement Regulatory Authority (PPRA) under the following categories:

Code 319: ICT Consultancy Services
Subcode 05: Telecommunications

4. International companies are not required to register with PPRA but must demonstrate legal registration in the country of origin.

5. International Bidders domiciled outside Botswana must, to be considered for the tender, submit company registration documents (in English or accompanied by an English translation) issued by the relevant authorities.

6. Citizen Economic Empowerment Policy (CEEP) shall apply to this tender. Bidders are requested to submit relevant certificates to benefit from the CEEP scheme.

7. Citizen youth-owned companies shall purchase the ITT at 50% of the fee as per **Presidential Directive CAB 14 (B)/ 2015**.

8. The Invitation to Tender (ITT) document may be purchased by interested companies at a non-refundable fee of **P285.00 (Two Hundred and Eighty-Five Pula Only) VAT Inclusive**. Payment must be made in the form of bank transfer or deposit at the following bank details:
