The Botswana Communications Regulatory Authority (BOCRA or the Authority) hereby invites 100% citizen owned companies to tender for the Provision of Consultancy Services for Quality Assurance of Botswana National Radio Frequency Plan.

The consultancy shall focus on ensuring that the Botswana National Radio Frequency Plan is up to date, consistent with the latest edition of the Southern African Development Community Frequency Allocation Plan (SADC FAP) and reflects the Final Regulations of the latest World Radio Communication Conference of 2023 (WRC 2023) more specifically the current Article 5 of the International Telecommunications Union Radio Regulations.

The tender is reserved for 100% citizen owned companies who are domiciled in Botswana and registered with the Public Procurement Regulatory Authority (PPRA) under the following categories:

Subcode 05: Telecommunications

Companies may subcontract up to 30% of the contract to international companies.
